## 1. Information We Collect

- **Automated Device Information (Log Files):** Like most standard websites, Mannacote automatically gathers technical information sent by your web browser. This includes your Internet Protocol (IP) address, browser type, Internet Service Provider (ISP), date/time stamps, referring or exit pages, and the number of clicks made while exploring our sections. This data is entirely aggregated and is not linked to any personally identifiable information.

## 2. Cookies and Web Beacons

Mannacote utilizes “cookies” to store information regarding visitors’ individual preferences and the specific pages accessed. This allows us to optimize our web page layout based on your browser type or geographical preferences, ensuring a smoother user experience. You can choose to disable cookies

through your individual browser settings if you prefer.

We work with third-party advertising frameworks (such as Google AdSense) and programmatic monetization networks to display relevant banners and promotional links.
